**ARTICLES OF INCORPORATION
(Not for Profit)
OF**

BEHIND OUR EYES, INC.

Article I – Name

The name of the Corporation shall be Behind Our Eyes, Inc.

Article II – Principal Office

The principal place of business and mailing address of the Corporation is 3333 NE 34th Street, #403, Fort Lauderdale, Florida 33308.

Article III - Purpose

The specific purpose for which this Corporation is organized is to support and develop the writings of persons with disabilities and, further, to promote public awareness of persons with disabilities, through lectures, workshops, writing exercises, the publication and dissemination of written works, and other means.

The Corporation is organized exclusively for educational and/or literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

The name and address of the initial registered agent is Sanford Rosenthal, 3333 NE 34th Street, #403, Fort Lauderdale, Florida 33308.

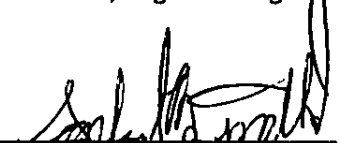
Article VI – Incorporator(s)
