**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
MT. PLEASANT MISSIONARY BAPTIST
CHURCH OF THE KINGDOM, INC.
(a Florida Corporation Not for Profit)**

Pursuant to Sections 617.1006, *Florida Statutes*, Mt. Pleasant Missionary Baptist Church of The Kingdom, Inc., a Florida not-for-profit corporation (the "Corporation"), which bears Florida Document Number N09000001599, adopts the following amendment to its Articles of Incorporation.

FIRST: Article 1, Name of the Corporation's Articles of Incorporation is deleted in its entirety and the following shall be substituted in lieu thereof:

ARTICLE 1.

Name

The name of this Corporation is Mt. Pleasant Kingdom Ministries, Inc.
(hereinafter called the "Corporation").

SECOND: There are no members entitled to vote on this Amendment. This Amendment and the corresponding name change were approved by the Corporation by Unanimous Written Action dated April 26, 2011, duly executed by all of the Corporation's Directors entitled to vote on such matter.

THIRD: The effective date of this Amendment is the date of filing of these Articles of Amendment.

IN WITNESS WHEREOF, the undersigned has executed these Articles of Amendment to the Articles of Incorporation for and on behalf of the Corporation as its duly authorized representative in his capacity as President thereof, on the 26th day of April, 2011.
