The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statues, adopts the following Articles of Incorporation for such corporation:

### ARTICLE I. NAME

### ARTICLE II ADDRESS

## ARTICLE III. CORPORATE NATURE

This is a nonprofit corporation organized solely for general educational purposes pursuant to the Florida Statues, Section 617. of the Florida Not For Profit Corporation Act.

### ARTICLE IV. DURATION

The duration of this corporation is perpetual unless sooner dissolved according to law. Corporate existence shall commence on the filling of these articles by the Department of State.

### ARTICLE VII. EARNINGS AND ACTIVITIES OF CORPORATION

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) or the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of this corporation.

### ARTICLE VIII. DISTRIBUTION OF ASSETS

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501  $\mathbb{Q}(3)$  of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.
