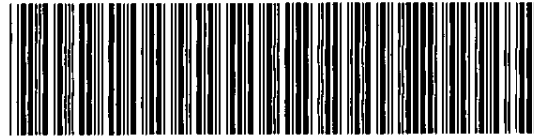

ARTICLE II

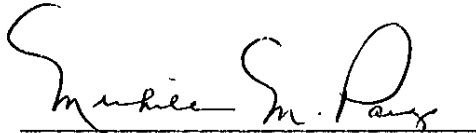
The document number of the Corporation is N09000001641.
