The undersigned, acting as incorporator (s) of a Corporation pursuant to Chapter 617, Florida Statues, adopt (s) the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be, EMMANUEL OUTREACH

CENTER, INC. The principal place of business of this corporation shall be

The corporation shall have perpetual existence, or until dissolved according to law.
