**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I ORGANIZATION**

The name of this organization, founded as a non-profit corporation shall be known as The Krewe of Behaim, Inc. A shortened version of the name is allowable for all communications. The Corporation shall retain the exclusive and sole right to use, or allow to refuse the use of all emblems, seals, badges, or other items incorporating the words "The Krewe of Behaim" and/or "Krewe of Behaim".

**ARTICLE II ADDRESS**

The principal place of business and mailing address of the corporation The Krewe of Behaim shall be: 4215 West Kensington Avenue Tampa, Florida 33629

**ARTICLE III PURPOSE**

The purposes of The Krewe of Behaim are exclusively social, not for profit and are to:

1. Provide a social environment for the development of friendships.
2. Support Krewe members in individual endeavors.
3. Lend time and expertise in giving back to our community.

**ARTICLE IV MANNER OF ELECTION**

1. There shall be Officers consisting of a Captain (president), First Mate (vice-president), Quartermaster (secretary), Boatswain (treasurer), Gunner (historian), Coxswain (committee chair), and Mate (member at large) which hereafter shall be referred to as Krewe Council
2. Elections for Krewe Council shall be conducted as determined in the Policies and Procedures.
3. The qualifications for each member of the Krewe Council will be outlined in the Policies and Procedures. Qualifications must be met as of the date elections.

**ARTICLE V REGISTERED AGENT**

**ARTICLE VI INCORPORATOR**


The Incorporator of The Krewe of Behaim shall be Barbara Miraglia who resides at 4215 West Kensington Avenue Tampa, Florida 33629.
