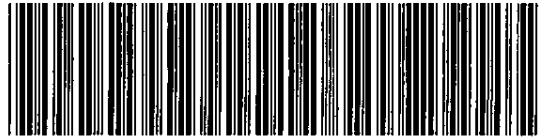

## ARTICLES OF INCORPORATION

David Clowney Foundation, Inc.

EIN# 30-0516286

*In Compliance with Chapter 617.0202, F.S. (Not for Profit)*

### **Article I: Name of Corporation**

The name of the corporation shall be the **David Clowney Foundation, Inc.**

### **Article II: Principal Address**

The principal address of the corporation shall be **806 Sun Valley Way, Florham Park, New Jersey, 07932**

### **Article III: Purpose**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose for which the corporation is organized is **to inspire disadvantaged inner-city youth in South Florida to pursue academic achievement by providing mentorship, leadership, and financial support to any youth with a desire to go to college.** The Foundation partners with community agencies and schools to lead underprivileged city youth towards receiving a college education, raising money for youth programs and scholarships. The David Clowney Foundation, Inc. seeks to create a model program and philosophy that can be shared with disadvantaged city youth throughout the nation. The David Clowney Foundation, Inc. also supports charitable efforts for community agencies in South Florida and nationally, empowering individuals and families to create a better life for themselves.

### **Article IV: Appointment of Directors**

The directors of said corporation shall be elected or appointed to represent said corporation in a self-perpetuating format, with input for nominating new board members to be provided by a board committee. The full board will vote to elect any new board members, with a majority vote being required for confirmation of membership on the board of directors. Directors of said corporation shall be appointed for a two-year term with re-appointment contingent on a majority vote by the board of directors.

### **Article VIII: Limitations**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### **Article IX: Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
