#### ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not for Profit)

#### ARTICLE I - NAME

The name of the corporation shall be: The Quest Christian Mission, Inc.

#### ARTICLE II - PRINCIPAL OFFICE

The principle place of business and mailing address of this corporation shall be: The Quest Christian Mission, Inc, 20100 SW 115<sup>th</sup> Ave Miami, Florida 33189

### **ARTICLE III – PURPOSE**

The purpose for which the corporation is organized: The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

# ARTICLE IV - EARNINGS, COMPENSATION, ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be, distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE V - DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the

County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

#### ARTICLE VI - MANNER OF ELECTION

The manner in which the directors are elected or appointed is as follows:

- (1) Until such time as this ministry establishes a qualified corporation membership constituency of 100 members a temporary board shall be appointed by those forming the corporation to serve as the initial board of directors. This initial board may make additional appointments to the board, as needed, until a qualified corporation membership constituency is obtained.
- (2) After a qualified corporation membership constituency is attained future election of officers to the board will be by corporation membership vote. The election of board members shall be divided into thirds: one-third for a three-year term, one-third for a two-year term and one-third for a one-year term. After the initial election all terms shall be for three years.
- (3) Any person contributing \$100 or more annually shall become eligible to membership in the above corporation. Any member of the Corporation shall have the full right to vote or act by proxy so long as said membership shall continue and said member is a member in good standing of a local Christian church.
