



**AMENDMENTS ADOPTED**

**Article XV**

**(Original Spanish Version Attached)**

The members must be: Founders (members from the beginning), actives, honorary or subscribers.

- a. Founders members will be the concurrent to the institution foundation and those who ever joined the institution within the next 30 days follow the foundation, considering our founders the following persons:



1ro Con respecto a los activos (vestuarios, instrumentos musicales, material visual, fotografías, videos, dance floor, utilería, accesorios en general y otros) que en sus inicios como institución y por medio de su propio peculio adquirieron los primeros activos y todo lo que se obtiene hasta el día de hoy RESUELVEN que en un eventual caso de DISOLUCION y evitar conflictos entre los asociados DONAR todo lo obtenido hasta el día de la disolución A instituciones culturales debidamente acreditadas. Y en el caso de que los fundadores arriba mencionados no se encontraran físicamente o mentalmente aptos para tomar una decisión sobre el destino del activo de la Institución se llamará al familiar más directo para que participe de este acto que damos fé como DESICION INAMOVIBLE de nuestra institución RITMOS PERU.

2do En el caso de que los FUNDADORES se encuentren participando o no activamente en el desarrollo de RITMOS PERU por diferentes circunstancias; tienen la facultad de fiscalizar, interpelar, pedir información en cualquiera de las áreas que desarrolla RITMOS PERU. Así mismo tienen el derecho de participar de TODAS las reuniones convocadas a los miembros de RITMOS PERU.

b) Serán socios activos los que tengan 2 años de antigüedad en el registro social y hayan cumplido regularmente con las obligaciones que impone este estatuto y establezcan los reglamentos generales de la institución.

c) Serán socios honorarios aquellas personas que, en razón de sus méritos o de los relevantes servicios prestados a la institución, sean designados tales por la Asamblea General.

d) Serán socios suscriptores los menores que no hayan cumplido 18 años y los que admitidos como asociados, no hayan cumplido aún las condiciones indicadas en el inciso b) de este artículo.

dissolution to cultural institutions properly certified and, in the event that the founders mentioned above, will not be physical or mentally capable to take decisions above the Institution assets, the direct closed family member will be called to participate in the act, to which we give faith as IMMOVABLE DECISION (IT CAN NOT BE MODIFIED/NOT MODIFIABLE DECISION) of our institution RITMOS PERU.

2. In the event that the FOUNDERS will be actives or no actives in the developing of RITMOS PERU by any circumstances; they have the faculty of inquiry, control, question, appeal, request information to any of the areas that develop RITMOS PERU. Likewise they have the right to participate in ALL the meetings called to the member of RITMOS PERU.
  - b. Active members will be all member that have two years length within the institution and that comply with the obligations imposed by the statutes and regulations/rules of the Institution.
  - c. Honorary member will be persons that, due to the merits or outstanding/relevant services given/granted to the institution. They will be designated by General Assembly.
  - d. Subscribers member will be the minors under 18 years old and those that were admitted as member but not complying with the conditions indicated on the part b of the article.
