Section E.

ARTICLE III - PURPOSE (AMENDED)

- 1. The Best Little Thrift Shop in Town, Inc. ("The Best") will resell donated clothing, furniture, housewares and other items in order to provide clothing, food, rent, and utility assistance to needy families in Lake County, Florida and surrounding areas. The Best will also make their organization facilities available to like-minded organizations, providing them with free auxiliary office space from which they may provide counseling and other services. This arrangement will allow a variety of organizations to work together in a synergistic fashion, and to better help those in need within the community. It is the hope of The Best that their efforts will bring about unity of purpose to the local philanthropic community.
- 2. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- 3. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

<u>ARTICLE VIII – DISSOLUTION</u>

1. Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government for public purpose. Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
