ARTICLES OF INCORPORATION OF ST. JOHN UNITED METHODIST CHURCH OF FORT PIERCE, INC. [A CORPORATION NOT FOR PROFIT]

WE, the undersigned members of ST. JOHN UNITED METHODIST CHURCH of Fort Pierce, Florida, hereby form ourselves and our successors into a corporation not for profit under the corporate name of ST. JOHN UNITED METHODIST CHURCH OF FORT PIERCE, INC., and hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be ST. JOHN UNITED METHODIST CHURCH OF FORT PIERCE, INC., and it is located at 302 North 23rd Street, Fort Pierce, Saint Lucie County, Florida 34950.

ARTICLE II

The general purpose of this corporation is to be recognized as a Christian Church in the community.

ARTICLE III

The general nature and object of this corporation is to buy, purchase, own, acquire by gift, devise, purchase or otherwise, real and personal property, and to build, erect, construct, provide for, maintain and equip suitable buildings, churches, houses, etc. for the benefit, use and occupation of said ST. JOHN UNITED METHODIST CHURCH OF FORT PIERCE, INC., its members and congregation, in maintaining and fostering public worship; and the preaching and teaching of the Word of God and the Gospel of Jesus Christ, and for all other meetings and purposes of the said ST. JOHN UNITED METHODIST CHURCH OF FORT PIERCE, INC., its members and congregation; to build, construct, erect, maintain and equip schools, mission stations and mission churches, pastor's home and such other houses and equipment as the church may desire for carrying on its work.

JOHN UNITED METHODIST CHURCH OF FORT PIERCE, INC., in good and regular standing, he/she shall cease to be a member of this corporation, and the vacancy may be filled by the members of the said church at any regular meeting of the said church, or at a special meeting called for that purpose.

ARTICLE VI

The term for which this corporation shall exist shall be perpetual.
