CERIFICATE OF REINCORPORATION

Pursuant to s. 317.0901, Florida Statutes, this certificate of reincorporation was duly authorized by a meeting of its board of directors:

Article I Name

The Name of the corporation shall be:
SAINT ANDREW'S EVANGELICAL LUTHERAN CHURCH OF HOMESTEAD, FLORIDA INC.

Article II Principle Office

The principle office of the business and mailing address of this corporation shall be:
1955 N. Krome Avenue, Homestead, FL 33030

Article III Purpose

The specific purpose for which the corporation is organized shall be:

- a. The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under Section 501(c)(3) of the Internal Revenue Code.
- b. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation of services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in , or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate of public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- c. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
- d. To provide a broad array of social and human services to the socio-economic disadvantaged residence of the Greater Homestead and Florida City areas.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the Corporation of Organization, shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of Section 501(c)(3) purposes.

Article IV
Manner of Election

The manner in which the directors are elected or appointed shall be:
The directors of the church shall be elected at an annual meeting called for such purpose and their term of office shall be provided for in the constitution of the congregation.
