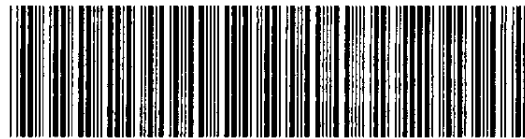

To achieve this objective Lady Razorbacks, Inc will provide a supervised program under the Rules and Polices of appropriate softball associations, including but not limited to Independent Softball Association and National Softball Association.

All Directors, officers and members shall bear in mind that the attainment of exceptional athletic skill of the winning of games is secondary, and the molding of future citizens is of prime importance. Lady Razorbacks, Inc shall operate exclusively as a non-profit education organization providing a supervised program of competitive softball games.

No part of the net earnings shall inure to benefit of any private shareholder or individual, no part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation, and which does not participate in or intervene in any political campaign on behalf of any candidate for public office.
