ARTICLE I

The name of the corporation shall be Tri-County Home Builders Association, Corp.

ARTICLE II

The Corporation's principal office is located at 949 Orange Hill Road, Chipley, FL 32428, Washington County. Mailing address is P.O. Box 84, Chipley, FL 32428.

ARTICLE III

Said corporation is organized exclusively for charitable and educational purposes in the promotion of the building and construction industries including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Codes, or the corresponding section of any future federal tax code.

ARTICLE IV

Directors will be appointed positions. Officers are elected by a majority vote of members present. The qualifications for members and the manner of their admissions shall be regulated by the by-laws.

ARTICLE V

ARTICLE VI

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, officers, directors or any private individual, except that reasonable compensation may be paid for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate

for public office. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable or education organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code.
