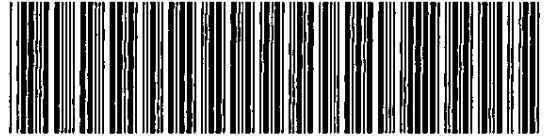

**ARTICLE III**  
**CORPORATE PURPOSES: POWERS**

This corporation is Non-Profit corporation and the purposes for which it has been organized are exclusively for charitable, literary and educational within the meaning of Section 501-©(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States internal revenue law, including the following specific purposes:

- 1) To proclaim the Gospel of he Kingdom and the Lordship of Jesus Christ.
- 2) To serve the surrounding Charitable communities in-carrying our the Great Commission ( Mathew 28: 18-20
- 3) To Help Batter Woman and Children and to help the youth on their Drug and Alcohol abuse
- 4) To strengthen the spiritual family of our community cooperative efforts.

As a mean s of accomplishing the above purposes and methods, the Corporation shall have the following powers:

- a) To accept, acquire, receive, take and hold by bequest, device, grant, gift purchase, exchange, lease, transfer, judicial order or decree, or other wise, for any of its objects and purposes, any property, both real and persona, of whatever kind, nature of description and wherever situated.
- b) To See, Exchange, convey, mortgage, lease transfer or otherwise dispose of, any such property, both real and personal, as the objects and purpose of the corporation may

require, subject to such limitations as may be prescribed by law.

c) to borrow money, and, from time to time, to make, accept, endorse, execute and issue bonds, debentures, promissory notes, bill of exchange, and other obligations of the Corporation for moneys borrowed or in payment of property acquired or for any of the purposes of the Corporation, and to secure the payment of any such obligations by mortgage, pledge, deed, indenture, agreement, or other instrument of trust, or by other lien upon, assignment of, or agreement in regard to all or any part of the property, rights, or privileges of the Corporation wherever is whether now owned or hereafter to be acquired. To invest and reinvest its funds in such stock. Common or preferred, debentures, mortgage, or in such other securities and property, and personal, as it shall deem advisable, subject to the limitations and conditions contained in any bequest, devise, grant or gift, provided such limitations conditions are not in conflict with the provisions of 501©(3) of the Internal Revenue Code of 1986 and applicable regulations hereunder as they now exist or as they may be amended.




