Articles of Incorporation of Making the Difference Outreach, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to act as the liaison between our community and chartable organizations in need to increase volunteer participation and donations. Also to provide a collaborative website where the community can go to register to volunteer or sponsor as needed.
