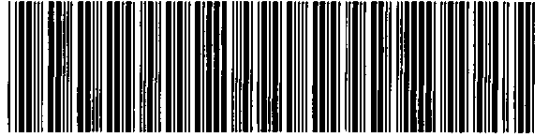


## ARTICLE X

The corporation shall be subject to the bylaws of Allied Veterans of the World, Inc. & Affiliates.


