The undersigned incorporator, for the purpose of forming a not-for-profit corporation in compliance with Chapter 617 of the <u>Florida Statutes</u>, hereby adopts the following Articles of Incorporation:

ARTICLE I - Name and Address

The name of the corporation is OPERATION: ENDURING GRATITUDE, INC. (hereinafter referred to as the "corporation"). The mailing address of the corporation is 2267 Springrain Drive, Clearwater, Florida 33763, and the address of the corporation's principal place of business is 2267 Springrain Drive, Clearwater, Florida 33763.

ARTICLE II - Duration

This corporation shall have perpetual existence.

ARTICLE III Purpose

- A. The specific and primary purpose for which the corporation is formed is to create, organize and implement, under the laws of the State of Florida, a network of retailers and service providers to become members, supporters, sponsors, and/or underwriters of the corporation by agreeing to provide a minimum ten percent (10%) discount on their services and products sold to and purchased by our United States Veterans.
- B. The general purpose for which the corporation is formed is to operate exclusively for purposes that will provide United States Veterans with discounted products and services, as well as qualifying it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code and Regulations (hereinafter referred to as the "Code") and corresponding provision of any subsequent federal tax laws, including for such purposes, the making of distributions or organizations which qualify as tax exempt organizations under the Code.

- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director or Officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be pald for services rendered to or for the corporation affecting one or more of its purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.
- D. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

ARTICLE IV - Directors

The initial Board of Directors shall consist of three (3) Members who shall have the power to notice, amend, and repeal the Bylaws of the corporation. The number of directors may be increased or decreased from time to time as set out in the Bylaws of the corporation, but the number of Directors shall never be less than three (3).
