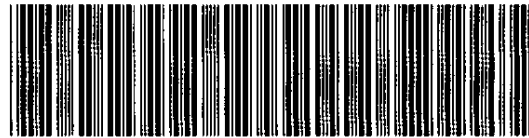

The following text is to replace text in Article III of original Articles of Incorporation. To solicit donations or earn funds in order to purchase and distribute items to enhance the wellbeing of Central Florida Residents who are in need of assistance. Whereas, said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 or the IRS tax code, or corresponding section of any future federal tax code. Upon dissolution of the organization assets shall be distributed for one or more exempt purposes within the meaning of Internal Revenue Code section 501(c)3, or corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

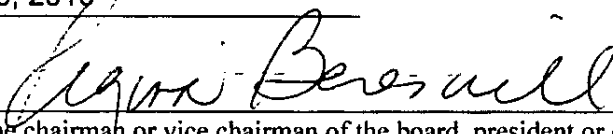
