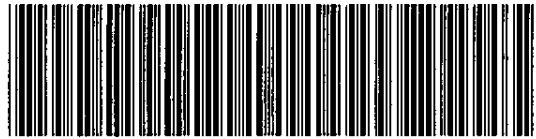

**ARTICLES OF INCORPORATION  
OF  
ALL OUT REPERTORY COMPANY, INC.**

The undersigned acting as the incorporator of a Not for Profit Corporation pursuant to Chapter 617 Florida Statutes, adopts the following Articles of Incorporation:

**Article I.**  
**Name**

The name of the corporation shall be **All Out Repertory Company, Inc.**

**Article II.**  
**Principal Office**

The principal place of business and mailing address of this corporation shall be 5919 N. Otis Ave, Tampa, FL 33604.

**Article III.**  
**Purpose**

The purposes for which the corporation is organized are:

a. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes, and shall be operated for the purpose of creating original works using and combining art forms, traditional and non-conventional; developing our professional arts community by creating local jobs and opportunities for national exposure to other artists and other arts communities; and enhancing the educational experience through the arts and enhancing the artistic experience through education. To these ends, the corporation may do and engage in any and all lawful activities that may be incidental or reasonably necessary to any of these purposes and that are not specifically prohibited under the laws of the State of Florida or of the United States.

b. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

c. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

d. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax

under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IV.**  
**Term of Existence**

The corporation shall have perpetual existence commencing with the filing of these Articles of Incorporation with the Secretary of State, State of Florida.

**Article V.**  
**Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article VI.**  
**Members**

The qualifications, rights and the manner for admission of members of the Corporation shall be specified in the Bylaws.

**Article VII.**  
**Directors**

The directors of the Corporation shall be elected in a manner set forth in the Bylaws. The names and addresses of the Corporation's initial directors are:

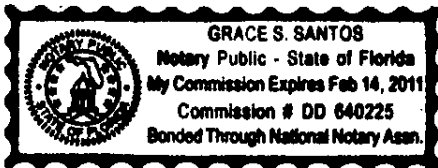

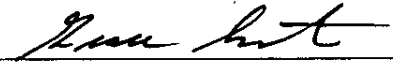
