The undersigned, acting as incorporators or a corporation pursuant to the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is COALICION CIVICA Y SOCIALES DE LAS NACIONES UNIDAS, INC.

ARTICLE II

The principal business and mailing address of the corporation is 2056 NW 23 Avenue, Miami, Florida 33142.

ARTICLE III

The specific purpose or purposes for which the corporation is organized is to provide disaster relief, humanitarian aid, immediate response to emergency medical needs, as well as supporting long-term humanitarian assistance programs, for all people around the world, irrespective of race, creed or political persuasion.


