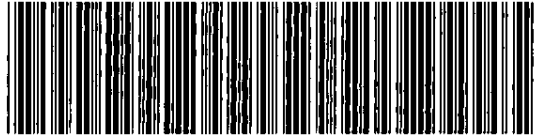

ARTICLES OF INCORPORATION

OF

CHUMUCKLA ATHLETIC ASSOCIATION, INC.

A Not-for-Profit Corporation

ARTICLE I - NAME

The name of this corporation is **CHUMUCKLA ATHLETIC ASSOCIATION, INC.**

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

(1) **CHUMUCKLA ATHLETIC ASSOCIATION, INC.** is organized to facilitate and encourage participation in sporting and athletic activities for the benefit and development of Chumuckla, Florida and the surrounding areas and all other lawful business.

Anything in these articles of incorporation to the contrary notwithstanding, the purpose or purposes for which this corporation is organized are limited to those that will qualify it as an example organization under Internal Revenue Code Section 501(c)(3), including, for those purposes, the making of distributions to organizations that qualify as tax-exempt organizations under the Internal Revenue Code.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

No part of the net earnings, properties or assets of this corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual or any member or director of this corporation. On liquidation or dissolution all properties and assets of this corporation remaining after paying or providing for all

debts and obligations shall be distributed and paid over to a fund, foundation or corporation organized and operated for charitable or religious purposes designated by the board of directors which shall at the time qualifies as a tax-exempt organization under Internal Revenue Code Section 501(c)(3), or as that statute may be amended.

ARTICLE IV - DIRECTORS

There shall be five (5) members of the initial Board of Directors of the corporation. The method of electing Directors shall be as stated in the Bylaws of the corporation. There shall be no less than three (3) members of the Board of Directors. The names and addresses of the persons who are to serve as the initial Directors are as follows:

ARTICLE V - MEMBERSHIP

Membership in the corporation shall be governed by the Bylaws, and the corporation is formed on a non-stock basis.

ARTICLE VI - REGISTERED OFFICE

AND REGISTERED AGENT

The initial principal office, and mailing address of the corporation shall be located at 2355 Highway 182, Jay, Florida 32565. The initial registered agent of the corporation at that address shall be Daniel P. Saba, Esquire, 4557 Chumuckla Highway, Pace, FL 32571.

ARTICLE VII - INCORPORATORS

ARTICLE VIII - OFFICERS

Section 1. The officers and agents of the corporation shall be a President, Vice-President, Secretary and Treasurer and any such other officers or agents as may be provided by the Bylaws or appointed and authorized by the Directors.

Section 2. The officers shall be elected at the annual meeting of the Board of Directors or as provided in the Bylaws.


ARTICLE IX - BYLAWS

The power to adopt, alter, amend or repeal Bylaws shall be by majority vote of the Board of Directors or by majority vote of the Members.

ARTICLE X - AMENDMENT

These Articles of Incorporation may be amended by an affirmative vote of 2/3 of the members of the corporation present at a meeting duly called for that purpose. Notice for a meeting called for the purpose of amending these Articles of Incorporation shall be satisfied if the date, time and place of the meeting is announced at a regular meeting of the corporation at least seven (7) days in advance of the meeting.

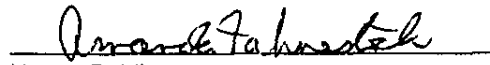
