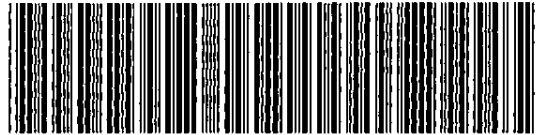

## ARTICLE VIII

Said corporation/ organization is organized exclusively for charitable, religious, Educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE IX

No part of the earning of the corporation/organization shall to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation/ organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of activities of the corporation/ organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not campaign on participate in, or intervene in ( including the publishing or distribution of statement) any political campaign on behalf of or in opposition to any candidate for public office.

## **ARTICLE X**

**Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activity permitted to be carried on(a) by a Corporation/organization exempt from Federal Income Tax under section 501( c ) (3) of the Internal Revenue Code, or the corresponding section of any future tax code, by a corporation/ organization, contribution to which are deductible under section 170 (c ) (2) of the Internal Revenue Code, or the corresponding tax section of any federal tax code.**

## **ARTICLE XI**

**Upon the dissolution of this corporation/organization, asset shall be distributed for one or more exempt purposes with the meaning of section 501 (c ) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be Distributed to the federal government, or to a state or local government, for a public purpose**
