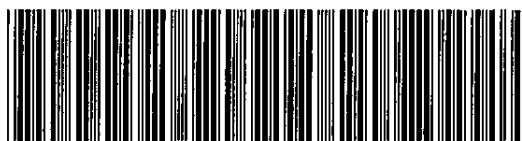

ARTICLES OF INCORPORATION

Community Fellowship Church of Clewiston, Inc

The undersign, acting as incorporators of a corporation under Chapter 617, F.S. the Not for Profit Corporation Act of State of Florida, adopt the following articles of incorporation for such corporation:

Article I

The name of the corporation, hereinafter referred to as the "Corporation is.
Community Fellowship Church of Clewiston, Inc

Article II

The period of duration of the Corporation is perpetual.

Article III

A. The purpose of the corporation as a local body of Christ shall glorify God through worship, develop growth and fellowship in the Lord Jesus, to communicate the gospel to the world and expand the body of Christ through the planting of additional local bodies.

B. The Corporation is organized exclusively for charitable, religious, educational, and scientific purpose, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in section A hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV

Election of directors is as stated in the by-laws. The qualification for members and the manner of their admissions shall be regulated by the by-laws.

Article V

The initial street address is 1227 Virginia Av *Clewiston* in the state of Florida

Article VI

Article VII

The territory in which the operations of the Corporation are principally to be conducted is the United States of America and its territories and possession, but the operation of the Corporation shall not be limited to such territory.
