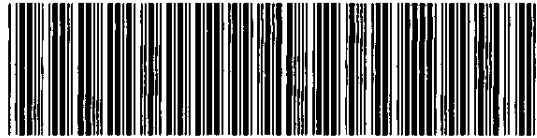

## ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I NAME**

The name of the corporation shall be:

The purpose for which the corporation is organized is:

This corporation is organized and operated exclusively for charitable/educational purposes, including, but not limited to the efficient handling of call activities in a call center environment, and within the meaning of 501(c)(3) of the Internal Revenue Code.

### **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

- A) The initial number of directors of this corporation shall be three (3)
- B) The number of directors of this corporation may be either increased or diminished from time to time by the board of directors in the accordance with the bylaws of this corporation, but shall never be less than three (3).
- C) Director's Quorum: majority of the directors in office, or else as specified in bylaws, but not less than 1/3 of the number in office.
- D) Director's term of office: as specified in bylaws
- E) Any director may be removed from office by the directors of this corporation in accordance with the bylaws of this corporation
- F) In case one or more vacancies shall occur in the board of directors by reason of death, resignations, or otherwise, the vacancies shall be filled in accordance with the bylaws of this corporation.

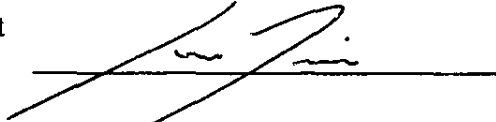

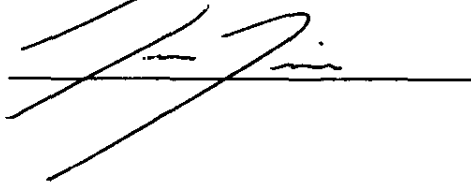
