

Amended Organizational Document for The Olive tree Foundation For Education Inc.

Tax ID 26-4393696

Notwithstanding any other provision of these articles, the Olive Tree Foundation for Education, Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, of the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose.

I, the undersigned, as a principal officer of the Olive Tree Foundation for Education Inc., do hereby agree that said organization is hereby classified as a publicly supported organization described in section 509(a)(1) and 170(b)(1)(A)(vi) of the Internal Revenue Code, rather than section 509 (a)(3).
