ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is organized and shall be operated as a non profit corporation solely and exclusively as a Christian Charitable Church in the Tampa, Florida area for charitable, educational, literacy and various outreach and community based programs. Biblical teachings, sacraments, baptisms, christenings, ordinations, communions, marriages, worship services and classes as is necessary to accomplish its expanding mission, Christian programs may be determined by the Board of Directors from time to time. The Corporation shall not perform any act or transact any business that will jeopardize the tax exempt status of the Corporation under Section 501(3)(c) of the Internal Revenue code and its regulations as such section and regulations now exist or may hereafter be amended or revised under corresponding laws and regulations hereafter adopted. Specific purposes for which the corporation is formed is as follows:

- Literacy and academic tutoring, instruction for training of individuals for the purpose of improving or developing their capabilities; and the instruction of the public on subjects useful to individuals and beneficial to the community; and
- Provision of food and other aid for relief to the poor, distressed, underprivileged, and/or economically disadvantaged
