# PIRST RESTATED AND AMENDED ARTICLES OF INCORPORATION OF SPENDFORED.ORG, INC.

Pursuant to the provisions of Chapter 617 of the Florida Statutes governing not for profit corporation, SPENDFORED.ORG, INC., a not for profit corporation formed under the laws of the State of Florida, adopts the following First Restated and Amended Articles of Incorporation. This First Restated and Amended Articles of Incorporation hereby supersedes all prior Articles of Incorporation and amendments.

There are no members, and therefore, this instrument was approved and adopted by the Board of Directors on April 8, 2011.

#### Article 1.

The name of the corporation is SPENDFORED.ORG, INC.

#### Article 2.

This corporation is formed and organized for the following purposes.

This corporation is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, as hereafter amended from time to time (or the corresponding provision of any future United States internal revenue laws) ("Internal Revenue Code"). Notwithstanding any of the provisions in these First Restated and Amended Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income taxation under the Internal Revenue Code (whether under the current section 501(c)(3), its amendments, or future corresponding provision) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (whether under the current section, its amendments, or future corresponding provision).

Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

#### Article 3.

The manner of election and appointment of officers and directors is set forth in the bylaws of the corporation if adopted. If no bylaws is adopted then the manner shall be governed by the applicable statutes.

#### Article 4.

The corporation shall have one or more classes of members as the board of directors determines. The board of directors, by resolution, may create in its sole discretion one or more classes of members and define the rights, obligations, and benefits of each such class. If any class of members is created, no membership certificates shall be issued. Currently, the corporation does not have members.
