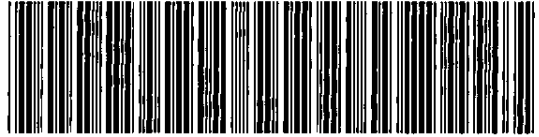

**Article VIII: Dissolution of Assets:**
