**ARTICLE ONE  
NAME AND ADDRESS**

The name of this corporation shall be **MYAKKA RIVER LODGE No. 2000, I.O.O.F., INC.**

**ARTICLE TWO  
PURPOSE**

- 3) Oscar Revilla

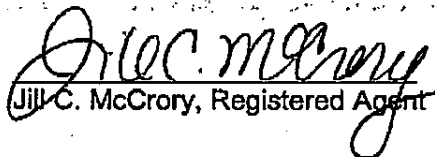

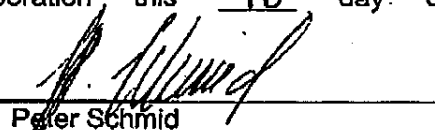
