The undersigned, acting as Incorporator of a corporation, adopts the following Articles of Incorporation for such corporation.

ARTICLE 1 NAME

The name of the Corporation shall be Betty Moore Ministries, Inc.

ARTICLE 11 MINISTRY LOCATION

The principal place of business address of this corporation shall be: 8959 Spring Harvest Lane West, Jacksonville, Florida 32244 where said principal office shall be, or at such other places as the Board of Directors from time to time properly designate. The mailing address shall be 9526 Argyle Forest Blvd, Ste #2, Jacksonville, Florida 32222.

ARTICLE 111 PURPOSE OF ORGANIZATION

The purposes for which the corporation was organized are:

- (a) Religious
- (b) To have an evangelistic outreach ministry that will teach and preach the Word of God.
- (c) To empower women (men) with Biblical principles for practical living, and develop a program for comprehensive studies that will promote partnerships within the communities.

ARTICLE IV ARTICLES OF FAITH

All beliefs within this organization are elucidated in the bylaws of the corporation.

This organization will cooperate with and mutually work with Temple Of Light Fellowship Ministries, and PROCLAIM Worldwide Inc.

ARTICLE VIII NONPROFIT STATUS AND LIQUIDATION

This organization is not organized for profit. In the event of liquidation or dissolution of Betty Moore Ministries, Inc. all of its assets and property of every nature and description whatsoever shall be paid over and transferred at the direction of the Board of Directors to Temple Of Light Fellowship Ministries and PROCLAIM Worldwide Inc.

ARTICLE IX AMENDMENT

This Constitution and Bylaws may be amended provided the proposed amendment shall have been presented in writing at a regular organizational meeting. Amendments to this Constitution and Bylaws shall be two-thirds vote of board members who are in good standing with the organization.
