ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF OCEAN 2 TRAIL, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Not For Profit Corporation Act, OCEAN 2 TRAIL, INC., a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the corporation is OCEAN 2 TRAIL, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on March 11, 2009.

ARTICLE II

Article V of the Articles of Incorporation of this Corporation is hereby amended for the purposes of changing the name of the corporation by deleting the existing Article I in its entirety, and substituting the following therefore to wir:

"ARTICLE V Directors

- (a) All corporate powers shall be exercised by or under the authority of, and the affairs of this corporation shall be managed by, a Board of Directors.
- (b) The names and addresses of the members of the Board of Directors of the corporation are as follows:

(c) The manner in which future directors are to be elected or appointed shall be as set forth in the bylaws of the corporation. The number of directors may be increased or decreased in the manner provided in the bylaws of the corporation, but the corporation shall always have at least three (3) directors."
