ARTICLES OF INCORPORATION OF HH POPE SHENOUDAH III SENIORS HOUSING ASSOCIATION, INC.

I, the undersigned natural person over the age of eighteen (18), acting as an incorporator, adopt the following Articles of Incorporation of HH POPE SHENOUDAH III SENIORS HOUSING ASSOCIATION, INC (the "Corporation") pursuant to the provisions of Chapter 617, Florida Statutes (FS) Non-Profit Corporation Act (the "Act").

ARTICLE I

The name of the Corporation is HH POPE SHENOUDAH III SENIORS HOUSING SASSOCIATION, INC. With its principal address located at 1110 John McCain Street
Colleyville, TX. 76034

ARTICLE II

The Corporation is a non-profit Corporation. Upon dissolution, all of the Corporation assets shall be distributed as set forth in Article VIII below.

ARTICLE III

The period of the Corporation duration is perpetual.

ARTICLE IV

The Corporation is organized exclusively for making affordable housing available to the seniors and elderly members of the Coptic Orthodox community in North America as reflected in its adopted Bylaws of HH POPE SHENOUDAH III SENIORS HOUSING ASSOCIATION, INC as each shall be amended from time to time.

ARTICLE V

Except as otherwise provided in these Articles, the Corporation shall have all of the powers provided in the Act. Moreover, the Corporation shall have all implied powers necessary and proper to carry out its express powers. The Corporation may pay reasonable compensation to trustees, officers or other persons for services rendered to or for the Corporation in furtherance of one or more of the purposes set forth above.

ARTICLE VI

No part of the income of the Corporation shall inure to the benefit of, or be distributable to, its trustees, officers, or other private persons, except that, as set forth in Article V above, the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. The Corporation shall have no power to take any action prohibited by the Act. The Corporation shall have no power to take any action that would be inconsistent with the

requirements for a tax exemption under Internal Revenue Code Section 501(c)(3) and related regulations, rulings, and procedures. The Corporation shall have no power to take any action that would be inconsistent with the requirements for receiving tax - deductible charitable contributions under Internal Revenue Code Section 1 70(c)(2) and related regulations, rulings and procedures. Regardless of any other provision in these Articles of Incorporation or state law, the Corporation shall have no power to:

- 1. Engage in activities or use its assets in manners that are not in furtherance of one or more exempt purposes, as set forth above and defined by the Internal Revenue Code and related regulations, rulings, and procedures, except to an insubstantial degree.
- 2. Serve a private interest other than one that is clearly incidental to an overriding public interest.
- 3.Devote more than an insubstantial part of its activities to attempting to influence legislation by propaganda or otherwise, except as provided by the Internal Revenue Code and related regulations, rulings, and procedures.
- 4. Participate in or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office. The prohibited activities include the publishing or distributing of statements and any other direct or indirect campaign activities.
- 5. Have objectives that characterize it as an "action organization" as defined by the Internal Revenue Code and related regulations, rulings, and procedures.
- 6.Distribute its assets on dissolution other than for one or more exempt purposes; on dissolution, the Corporation's assets shall be distributed to one or more of the Coptic Orthodox Churches located in the Diocese of Southern United States, as set forth in Article VIII herein.
- 7.Permit any pan of the net earnings of the Corporation to inure to the benefit of an private shareholder or member of the Corporation or any private individual.

ARTICLE VII

The Corporation herein adopts for observance and compliance all of the indemnity provisions of chapter 617 of Florida Statutes (FS), now existing or subsequently amended (herein referred to as "the Article") wherein any member of the Board of Trustees heretofore, presently or hereafter serving as a member of the Board of Trustees, is threatened to be named as a Defendant or Respondent in a proceeding solely because such person was a trustee, be indemnified by the Corporation in accordance with the provisions of the Article, if such trustee was acting in compliance with the Article, and not under the exceptions as stated in the Article.

ARTICLE VIII

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of

the assets of the Corporation exclusively for or to one or more of the Coptic Orthodox Churches located in the Diocese of the Southern United States, organized and operated exclusively for charitable and religious purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IX

The street address of the Corporation's initial registered office H10 John McCain Road, Calley Hile, Tokks 76034, and the name of its initial registered agent is Fr. Kyrillos Makar residing at 2930 County Rd 193, Clearwater, FL. 33759

ARTICLE X

The Corporation shall have no members.

ARTICLE XI

The Corporation shall be governed by a Board of Directors hereinafter referred to as the Board of Trustees which shall consist of no less than three members. The Bishop of the Coptic Orthodox Diocese of the Southern United States and his successors in office shall, by virtue of his office, be a Trustee of this Corporation. Two or more persons selected by the Bishop from among the priests, deacons, or the members of Coptic Orthodox Congregation will serve on the Board in the manner provided from time to time by the rules and regulations of its adopted Bylaws and as guided by the rules of the Synod Committee for the Coptic Churches in Immigration or by the Coptic Orthodox Diocese of the Southern United States. The Bishop and such other persons shall together constitute the Board of Trustees thereof. The Trustees of HH POPE SHENOUDAH III SENIORS HOUSING ASSOCIATION, INC shall exercise their powers in accordance with the rules, statutes, regulations and usage of the. Coptic Church of Alexandria Bylaws adopted by Synodical Committee for the Coptic Churches In Immigration, provided, however, that no act or proceeding of the Trustees of this Corporation shall be valid without the approval of the Bishop of the Diocese or, in case of his absence or inability to act, without the approval of the Vicar of such Diocese.

ARTICLE XII

The names and addresses of the Trustees who are to serve as the initial Board of Trustees for the first year or until their successors are selected according to the rules and regulation of the Coptic Orthodox Diocese of Southern US or Synodical Committee for the Coptic Churches in Immigration are:
