Article III:

What is the purpose for which the organization is organized?

The primary objectives and purposes of Canine Recourse shall be to serve and educate the public by:

- Advancing the potential of at-risk youth by providing them with essential developmental assets which are necessary to becoming a productive member of society. An example of the targeted assets will be;
 - Empowerment
 - Support
 - Constructive use of time
 - Positive values
 - Social competencies
 - Positive identity

These assets will be provided via the implementation of a professionally designed ***At-risk Youth Search and Rescue Dog Training*** curriculum. The curriculum will cover numerous stress and anger management skills as well as parenting skills using dogs as a catharsis. The dogs will be trained for ***Wilderness Search and Rescue*** purposes (lost individuals) as well as ***Disaster Search and Rescue*** (hurricane victims). The dogs would eventually be placed with local crisis response emergency teams or with the graduating youth themselves. The youth trainers will be charting on the dog's progress and the Canine Recourse instructors will chart on the youth's progress for evidence based services purposes.

- ***Training and providing Assistance Dogs*** to Floridians living with physical and/or developmental disabilities and to the growing elderly population in order to enhance their lives through independence. This facet of training also will be implemented by At-risk Youth, under the same charting parameter as the Search and Rescue training stated above.
- Performing ***Outreach and Education*** within our communities by implementing a structured after school drop-in program for at-risk youth and offering presentations such as "Dog bite prevention" at various community gatherings.
- Conducting ***Agricultural Canine Scent Detection Research*** in order to further the dog's abilities in regards to supporting Florida's farming industry. The research will involve training dogs to alert to specific agricultural parasites in order to prevent infestations. (ex: citrus canker, tomato white flies, etc.) The research will be documented on multi-media, including paper, computers and video. The research will be done in partnership with various professional entomologists and crop growers.
