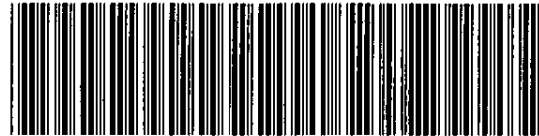

ARTICLE III- PURPOSE

1. Peruvian Foundation in Jacksonville, Inc. has been organized in order to secure funds to implement and support programs in Peru that will improve the quality of life of the poor and vulnerable through education, training and job opportunities.
2. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
3. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
