c) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section  $501\mathbb{Q}(3)$  of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
