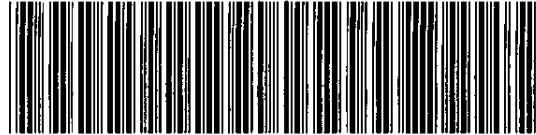




VIII
