

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Non for Profit)

ARTICLE I: NAME

The name of the Corporation shall be **MINISTERIO PROFETICO LA VOZ DE DIOS INC.** hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the corporation is **4508 5th Street West, Lehigh Acres, Florida 33971.**

ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSES

The purpose for which the corporation is organized is: exclusively for educational, religious and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (I) be a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, (or the corresponding provision of an future United States Internal Revenue Law), of (II) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of an future United States Internal Revenue Law).

ARTICLE V: RESTRICTIONS ON ACTIVITIES

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE VI: MANNER OF ELECTION

The manner in which the directors are elected or appointed: shall be appointed as provided for in the bylaws. The Board of Directors shall consist of THREE (3) persons.

The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however, there shall never be less than three directors.


