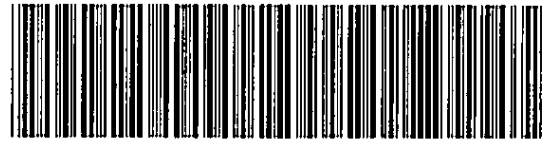

Recap of events that occurred during and after the Insurrection.

Recovery from this cybercrime is still on going. Discover of this shocking event is still becoming evident.

If Google ever cancels your account for *any reason* (example-logging into Google using the wrong password over and over), you most likely will **not** have it restored. There is no avenue for support. I am unable to restore my website, Facebook, Gmail, and so much more. Recently I was shocked to find my access to my health insurance not possible due to the hijacking of Professional and Personal email accounts. Be aware, be very aware of insurrectionists.

A cybercrime has been reported to the FBI and other agencies for their disposal.

As a recap,

Vic Ferguson, the executive director and founder of The World Federation for Coral Reef Conservation did conceive and develop the nonprofit organization (**WFCRC**) and administer to the same for over 13 years. Operational Capital was loaded (\$94,229.88) to **WFCRC** with the understanding that repayment would be returned to Vic Ferguson. A Mechanic's Lien now exist for repayment

During that time a decision was made to move **WFCRC** from Houston, Texas to Sebring, FL and to create a board of directors. The Board of Directorship was extended to:

It became evident that over time the board's participating in any effort to provide support and to further the organization was consistently ignored in the execution of any and all efforts and negotiations to further the success of **WFCRC**, and was **ONLY** addresses by the director.

On 2/1/21 (0800) the decision to remove the current board of directors due to noncompliance, was made by Vic Ferguson, the director/founder and was to have been delivered to the board during a zoom meeting which immediately turned into a shouting match making any additional communication with the directors impossible. So the actors listed above were removed in absentia.

SunBiz Division of Corporations, State documents were altered by the bad actors with no authority and have now been returned to the original document for corporations. As this document repository only records changes and does not administer to validity of documents. This has created the second change in our corporation docs due to the insurrection. Be advised that this event initiated by the director is the **only official change**, any other efforts to alter state docs should be considered fraudulent.

Threatening letters have been delivered to Vic Ferguson via regular mail as well as someone delivering a hand written threat that if "*I do not stop pushing back on their theft of **WFCRC**, there would be repercussions*". This note was placed in personal domicile making a criminal trespass. With the alleged connection to Organized Crime and the close relationship that UnderPressure Sports enjoys with local law enforcement, I am now concerned for my personal wellbeing. Should anything happen to me, these are the probably responsible parties.

The effort to engage directors in its daily operation was met with total negativity and dissention. When ask to participate in any activity to support WFCRC, the Board and Advisory Committee responded with "*they do not have the time*". This is a clear case of insubordination and is the "for cause" removal of all board members listed above.

As per **WFCRC** By Laws, Article 6 –Board of Directors, Directors and Board Members *must*:

Attend board meetings

Make serious commitment to participate actively

Volunteer for and willingly accepts assignments

Stay informed about board matters

Build working relationships

Actively participate in boards efforts

Participate in fund raising efforts

Departure from these By Laws are grounds for immediate removal. None of the above actions were ever undertaken by directors and/or committee members, which is a breach of Article 6 of the By Laws of The World Federation for Coral Reef Conservation.

As a result of the removal of these bad actors they had no equity and/or voting privileges and therefore *no* power to remove me as director, and most recently, their removal of me as the founder. Again this theft is an attempt to subvert years of conservation efforts around the world. It is still unclear the reasons these bad actors felt that it was acceptable behavior to steal what someone else has developed for years, just because they want it. In polite and educated societies this behavior is unacceptable and considered criminal. Why do they want this particular organization (**WFCRC**) and why don't they create their own organization and spend the money (\$94,220.88)

necessary to do it. Clearly, the notoriety and professional credentials created over the years (13) is the desired object of the theft of the organization.

A certified letter was sent to the actors listed above, was delivered to UnderPressure Sports location in Sebring, Florida demanding either payment the lien or restore all material stolen. The deadline to respond expired 7/23/21.

The thief and deception of these actors is the very description of what *Elderly Fraud* is. As the executive director/founder, I am a 73 year old Geologists still engaged in conservations efforts and are not as versed in the Internet activities as the younger generations. My life time focus is *now* and for *the balance of time*, on coral reef conservation.

On a positive note, **WFCRC** has entered into a partnership with The Press Release is now available. We have new and exciting projects like our National Coral Reef Registry and artificial reef planting. We have new board members and corporate structure.

It has now become clear that these bad actors are going so far as to contact professional associates in an effort to continue to disrupt **WFCRC**, please accept my apologies for any contact they may perform. Should you be contacted for any reason, ask them for an email and send it to me, it helps build my case against the insurrectionist.

The similarity between the Insurrection on Jan. 6 are closely reflected in this cybercrime by the bad actors listed above
