Change 3: Articles of Incorporation of Wat Buddhasaengdham (Continued)

Article XIII - Powers;

The Board of Directors shall have the power to admit by invitation as associate, honorary, sustaining or other members of this Corporation and for such period as they may elect, such persons of prominence or note, as it may think proper, or such persons that may render this Corporation any single benefit or service which it may wish to recognize in this manner and to renew such invitations at its discretion. Such members shall enjoy such privileges and benefits as may be determined by the Board of Directors. The Board Members must serve the temple regularly. Buddhist Monks may serve on the Executive Board when elected by a majority vote (51%) of the membership present at a special election and serve for a two (2) year term, however if reelected, may serve with no term limitations. If elected he must serve the temple according to the Buddhist disciplines and the state laws of Florida. Should the Monk need to take care of any necessary business, he may travel to complete his job and return to the temple within 120 days, or he may get approval from the Board of Directors for an extension; otherwise his position on the Executive Board may be ended. Board Membership is ended, unless reelected, when his term expires, resignation, death, or removal by majority vote of the Board of Directors. Only Monks assigned and living in the temple can be Board Members.
