

**ARTICLES OF INCORPORATION
FOR
FIRE & IRON FIREFIGHTERS
MOTORCYCLE CLUB INC. – STATION 42**

Article I Name:

The name of the corporation is Fire & Iron Firefighters Motorcycle Club Inc. - Station 42.

Article II Principal Office:

The principal place of business and mailing address shall be:

1619 Bryant Street
Kissimmee, FL 34746

Article III Purpose:

1. This corporation is a NON PROFIT PUBLIC BENEFIT CORPORATION and is not organized for the private gain of any person. It is organized under the Non Profit Public Benefit Corporation Law for public and charitable purposes.
2. The purpose for which the corporation is organized is to transact any lawful business for which Non Profit corporations may be organized under the laws of the State of Florida, as they may be amended from time to time and under Section 501 (c) 3, Internal Revenue Code. The primary, but not limiting, purpose of the corporation is to assist with raising funds for many different charities (March of Dimes, St. Jude's, Muscular Dystrophy, etc.) as voted on by the general membership through motorcycle rides and events.

Article IV Tax-Exempt Status:

1. This Corporation is organized and operated exclusively for charitable, public benefit and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future Federal tax code.
2. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not

participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office. Notwithstanding any other part of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or corresponding section of any future Federal tax code.

3. On the winding up and dissolution of this corporation, after paying or adequately providing for the debts, obligations, and liabilities of the corporation, the remaining assets of this corporation shall be distributed to a similar organization organized and operated exclusively for charitable and educational purposes that has established its tax-exempt status under Internal Revenue Code Section 501(c)3 or the corresponding provision of any future United States internal revenue law.

Article V Manner of Elections:

Elections are held on odd numbered years and officers will hold their position within the club for a period of two (2) years. Elections are opened up to all members in good standing; nominations are placed one month prior to the month of elections for the specific positions. Further details regarding the election, qualification, removal or resignation of directors are included in the By-laws of the Corporation.
