

**ARTICLES OF INCORPORATION OF

Whereas, it is deemed to be desirable and in the best interests of this Corporation and its shareholders that it be incorporated pursuant to the Florida Non Profit Corporation Act, Chapter 617; not therefore be it;

Resolved, that a certified copy of the original Articles of Incorporation for such corporation be attached hereto and that the following Articles of Incorporation be hereby adopted as follows:

The undersigned, acting as incorporators of a Florida corporation under the Florida Non-Profit Corporation Act, Chapter 617, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is UNIVERSITY INTERNATIONAL CONNECTION CHURCH, INC.

ARTICLE II. PRINCIPAL ADDRESS

The principal place of business and mailing address of this corporation is 12021 Socrates Drive, Orlando, Florida 32826.

ARTICLE VIII. DISSOLUTION OF CORPORATE AFFAIRS




