ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To operate and maintain the Hyde Park-St Paul (Walker) Cemetery for the interment of human remains of deceased persons the real estate, roadways, and other improvements thereon presently located in Wakulla County, Florida and to transact any and all lawful business for which cemeteries perform pursuant to applicable laws and regulation of the State of Florida.

ARTICLE IV DURATION/DISSOLUTION

The duration of the corporation shall be perpetual until dissolution.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected or appointed:

This corporation shall have members, the eligibility, rights and obligations of the members shall be determined by the corporation's bylaws. The management and affairs of the corporation shall be vested in a Board of Directors, as defined by the corporation's by-laws. No director of the corporation shall have right, title or interest in any property of the corporation. Members of the Board of Directors of the corporation are duly elected for a period of 2 years and are qualified and removed as provided in the corporation's by-laws.
