**ARTICLES OF INCORPORATION
FOR
SIMPLE AMERICAN, INC.
(Not-For-Profit)**

The undersigned, desiring to form a charitable corporation under Chapter 617, Florida Statutes, as amended, the Florida Not for Profit Corporation Act, does hereby adopt the following Articles of Incorporation and certify:

**ARTICLE I
NAME**

The name of the corporation shall be SIMPLE AMERICAN, INC.

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 3664 Coral Springs Drive, Coral Springs, Florida 33065.

**ARTICLE III
PURPOSE**

The corporation is a non-profit corporation formed for the purpose of bringing reforming to government by advocating for central campaign finance distributions, lobby reform and for reinstatement of civics education courses for grades K-12.

**ARTICLE IV
MANNER OF ELECTION**

In the event of liquidation or dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all assets of the Corporation to any exempt organization(s) under Section 501(C)(3) as the Board of Directors shall determine.
