**ARTICLES OF DISSOLUTION  
OF THE SHAIKH FOUNDATION, INC.**

Pursuant to the provisions of Sections 617.1402 and 617.1403 of the Florida Statutes, the undersigned Florida not for profit corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is THE SHAIKH FOUNDATION, INC. (hereinafter referred to as the "Corporation"). The Corporation was formed effective March 4, 2008. The Florida document number of the Corporation is N09000002951.

Article II - Date Dissolution Authorized

The dissolution of the Corporation was authorized on September 3, 2010.

Article III - Approval of Dissolution

No members of the Corporation are entitled to vote on its dissolution. The dissolution was approved by all members of the Board of Directors of the Corporation by written consent dated September 3, 2010 pursuant to Section 617.0821 of the Florida Statutes.
