We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to Chapter 617.0202, Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be Krunk for Christ Mentoring Ministry, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the membership of the corporation. The mailing address is: 109 Rosana Drive, Brandon, Florida 33511.

ARTICLE III: PURPOSE

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code. The charitable purposes for which this corporation not for profit is organized are as follows:

1. To advocate for children expelled or suspended from public or private schools.
2. To have legal services provided by attorneys at reduced cost.
3. To provide mentoring and fellowship services to youth through outreach, classes and communication geared towards but not limited to; well being, personal hygiene, spiritual education, morals, and how to cope with societal issues through non-violence.

4. To provide a clothes closet to under-privileged families in need.
5. To provide Christian counseling to individuals and families in need.

ARTICLE IV: BOARD OF DIRECTORS

The Board of Directors shall be elected at the annual meeting of the directors and each directors shall hold office for a term determined by the board of directors and until his successor is duly elected and qualified or until his death, resignation or removal from office.

ARTICLE V: OFFICERS

The officers of the corporation shall be President, Vice President, Treasurer, Secretary and other officers as provided by the By-Laws. The name of the office and the persons who are to serve as officers are as follows:

ARTICLE VI: REGISTERED AGENT

ARTICLE VII: BASIS OF OPERATION

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under

section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VIII: DISSOLUTION



ARTICLE IX: INCORPORATOR


