### **Articles of Amendment 1**

### Conflict of Interest Policy

The Mt. Olive Missionary Baptist Church of Groveland, Inc. considers the following practices to be a Conflict of Interest:

- Consideration for scholarships or other benefits of the organization that are based solely on relationship to a Board member,
- Membership on the Board that is based solely on personal gain,
- · Participation in agency activities that are based solely on personal gain,
- Illegal misuse of agency property, identity, or status,
- Conviction of a crime that could negatively impact the agency.
- Misrepresentation of the Mt. Olive Missionary Baptist Church of Groveland, Inc.

Should a <u>Conflict of Interest</u> be suspected, this information is to be presented to the Board, with substantive evidence, as soon as possible.

Should a <u>Conflict of Interest</u> issue be presented to the Board, an emergency meeting will be called within seven (7) days for the Board to collectively consider the matter.

The Board's final decision will be rendered by a two – thirds (2/3) vote of all members. Absent members may offer a vote within twenty four (24) hours of the meeting via telephone, email or facsimile on the matter, should they so choose.

The Board will render a final decision as to the outcome of this emergency meeting, in writing, to all involved parties, within forty – eight (48) hours of its decision.

The decision of the Board notwithstanding, the commission of any illegal activity by a participant in any agency activity will be reported to any and all law enforcement or other entity (such as the Department of Children and Families).

Should the same individual be brought to the attention of the Board more than three (3) times, they will be removed from their position in the agency, and will be excluded from future activities of the agencies.

Any person found to be conducting themselves in a manner that violates this policy will be immediately removed from their position, and excluded from all future activities of the Mt.

Olive Missionary Baptist Church of Groveland, Inc.

Any person found to commit a crime under the guise of the Mt. Olive Missionary Baptist Church of Groveland, Inc., will be prosecuted to the fullest extent of the law.

#### **Articles of Amendment 3**

### Purpose and Dissolution:

- a. Mt. Olive Missionary Baptist Church of Groveland, Inc., is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not disposed of shall by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organizations or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
