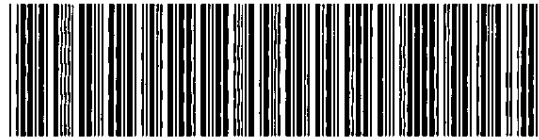

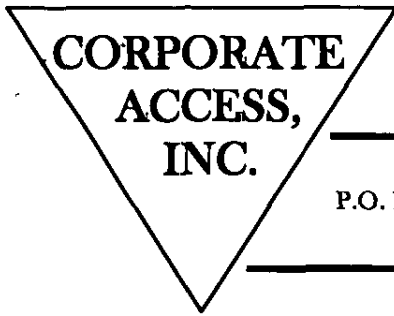

**ARTICLES OF INCORPORATION FOR
ST. MARY'S MISSIONARY BAPTIST CHURCH OF SILVER SPRINGS, INC.**

By these Articles of Incorporation (the "Articles"), the undersigned Incorporator forms a corporation "Not for profit" in accordance with chapter 617, Florida Statutes, and pursuant to the following provisions:

ARTICLE ONE

NAME

The name of the corporation shall be ST. MARY'S MISSIONARY BAPTIST CHURCH OF SILVER SPRINGS, INC., and the principal place of business of this corporation shall be: 3291 NE 55th Avenue, Silver Springs, Florida 34488. The mailing address is: P.O. Box 188, Silver Springs, FL 34489

ARTICLE TWO

COPORATE DURATION

The corporation shall exist perpetually unless and until dissolved according to law. Corporate existence shall commence upon the filling of these Articles with the Florida Department of State.

ARTICLE THREE

PURPOSE OR PURPOSES

The general nature of the purposes and objects of this corporation will be for the purpose of religious worships, and for carrying on of such other church functions that the congregation may deem necessary and proper; to acquire mortgage and sell property or properties in connection with its functions as a religious corporation.
