

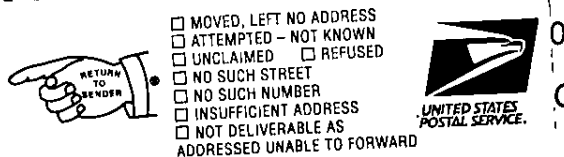

**ARTICLES OF INCORPORATION
OF
BEACHES CHRISTIAN COUNSELING CENTER, INC.
A Florida Not for Profit Corporation**

The undersigned, acting as incorporator of a corporation under the Florida Not for Profit Corporation Act, Florida Statutes, Title XXXVI, Chapter 617 (2007), adopts the following articles of incorporation for such corporation:

ARTICLE I

The name of the corporation, hereinafter referred to as the "Corporation" is
BEACHES CHRISTIAN COUNSELING CENTER, INC.

ARTICLE II

The period of duration of the Corporation is perpetual.

ARTICLE III

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The purposes of the Corporation include but are not limited to:

1. Contributing to exempt organizations under IRC section 501(c)(3).
2. Providing direct services, including counseling, treatment, instruction, alternative dispute resolution, including conflict mediation, and after-care support, to the local community and surrounding areas for mental health impairments; marital, family, and interpersonal relationship issues, including domestic violence; drug and other substance addictions; adult,

adolescent, or childhood emotional disorders; healing from grief, loss and trauma; and spiritual guidance under Christian principles.

3. Providing, promoting or supporting community mental and social health; education, including job and skills training; economic, religious, welfare and social improvements, including facilities, infrastructures, and services; decent, safe and sanitary affordable housing, including housing for indigent persons with mental health disabilities, shelters for persons who are homeless, transitional housing for persons under physical or mental health care, and supportive housing for persons with physical or mental health disabilities or impairments; benevolent food, clothing and material goods to indigent people; assistance to persons affected by emergencies, disasters, or other traumas; referral and coordination with other nonprofit organizations, schools or education systems, and governmental agencies; and volunteer services in support of the purposes of the Corporation.
4. Combating community deterioration; reducing poverty, crime, disease and environmental risks; and lessening governmental burdens through private initiatives for the purposes of the Corporation. Services and activities of the Corporation will be provided to persons or communities without regard to race or color, religion, national origin, age, gender, disability, military status, socioeconomic class or other characteristic protected under federal, state or local law or contrary to Christian principles.

The Corporation may receive and administer funds for scientific, religious, educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, the Corporation is empowered to hold

any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law.

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. The Corporation will not engage in prohibited political and legislative activity under 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE IV

The qualifications for Members, Directors and Officers and the manner of their admissions shall be regulated by the by-laws.

ARTICLE V

The initial street address in the State of Florida of the initial registered office of the Corporation is 422 5th Avenue North, Jacksonville Beach, Florida 32250.

ARTICLE VI

I, Joel D. Dalrymple, having been named as registered agent and to accept service of process for the above stated Corporation at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I

further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

ARTICLE VII

The territory in which the operations of the Corporation are principally to be conducted is the United States of America and its territories and possessions, but the operations of the Corporation shall not be limited to such territory.

ARTICLE VIII

The names and addresses of the persons who shall serve as Directors shall be named by separate resolution and enumerated in the Bylaws of the Corporation which shall be adopted by the Directors upon appointment.


