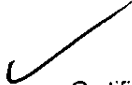

Article III

St. Paul Place Empowerment Center, Inc (here referred to as Paul's Place), formed as a Community Development Corporation. The purposes for which this corporation is formed are exclusively charitable educational and scientific consisting of the following: for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law." To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies. Our focus will be on meeting the needs of children and families in Apopka, Florida and the surroundings areas, through programs which include, but which will not limited to, pre-school and daycare for young children, after-school and tutoring programs, summer recreation programs, sports, arts and culture educational enhancement, and prevention programs. Paul's Place programs will also include elderly services, food distribution and family empowerment activities such as adult literacy high-school equivalency programs, job training and job placement, career enhancement services, advance the affordable housing, economic development, and community building strategies to assist families and communities toward self-sufficiency.

Article IV

Lobbying and Political Campaigns: No part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

Article V

DISSOLUTION: Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

Article VI

The manner of election of directors

Any Vacancy in the board may be filled for the unexpired term. The Directors shall be nominated and approved by the majority vote of present members. The number of directors shall never be less than three. The Directors of this corporation shall constitute persons hereinafter named as such other persons of good moral character may become a member.
